JOB GOAL:

To provide music instruction to students enrolled in music classes within the district.

PERFORMANCE RESPONSIBILITIES:

1. Establish and enforce rules for behavior and procedures for maintaining order among the students.
2. Observe and evaluate students' performance, behavior, and social development.
3. Prepare materials and classrooms for class activities.
4. Adapt teaching methods and instructional materials to meet students' varying needs and interests.
5. Observe, evaluate and grade students' class work, assignments, and papers, compile, administer, and grade examinations.
6. Initiate, facilitate, and moderate classroom discussions.
7. Keep current with developments in the field by reading current literature, participating in professional organizations, coursework and conferences.
8. Plan and conduct activities for a balanced program of instruction, demonstration, and work time that provides students with opportunities to observe, question, and investigate.
9. Establish clear objectives for all lessons, units, and projects based on the Maine Learning Results, the NafME National Music Standards, best practices, and communicate those objectives to the students.
10. Confer with parents or guardians, teachers, counselors, specialists, and administrators in order to assist/aid/improve students' overall performance in music.
11. Meet with parents and guardians to discuss their children's progress.
12. Maintain accurate and complete student records as required by laws, district policies, and administrative regulations.
13. Use technology and other equipment and materials to supplement presentations.

14. Prepare for assigned classes and show written evidence of preparation upon request of supervisors.
15. Attend staff meetings, professional meetings, educational conferences, and teacher training workshops and serve on committees in order to maintain and improve professional competence.
16. Perform administrative duties such as assisting with monitoring.
17. Collaborate with colleagues to address teaching and research issues.
18. Adhere to Individual Education Plans, 504 Accommodation Plans and differentiated instruction.
19. Coordinate the scheduling of concerts, festivals, and performances between building principal and staff, as well as music staff at other schools.
20. Perform all other related duties as assigned by the Building Administrators(s).

TERMS OF EMPLOYMENT:


