**I. PURPOSE OF THE EVALUATION**

The Superintendent and the Board of Education recognize the need to review the Superintendent's performance annually. This review will consist of the completion of a written appraisal instrument and the discussion of this instrument with the Superintendent in executive session. The intent of the evaluation is to:

- A. Arrive at certain conclusions as to the "effectiveness" of the Superintendent in achieving the objectives of the district and his job description.
- B. Communicate those conclusions to the Superintendent providing counsel and direction.
- C. Enhance the working relationship between the Board of Education and the Superintendent.
- D. Promote the professional development and growth of the Superintendent.
- E. Guide decisions relative to continued employment and compensation.

**II. PROCEDURES**

A. Time:

The annual evaluation shall be conducted in the month of May in conjunction with the Board's self-evaluation.

B. Methodology:

- 1. The superintendent completes a self-reflection and provides to the Personnel Committee chair by the first Board of Education business meeting in May.
- 2. Evaluation forms shall be given to Board members by early May
- 3. Board members will complete the instrument as individuals and provide to Personnel Chair.
- 4. The Personnel Committee Chair shall review individual input and complete a draft summary document.  
In executive session, the Board shall reach a consensus and the Board Chair will complete a summary document.
- 5. The Board of Education shall meet with the Superintendent in executive session to discuss the summary document and modify as appropriate.
- 6. The Superintendent and the Board chair will sign the modified document as an indication that the document has been reviewed. A copy will be placed in the Superintendent's personal folder and a copy given to the Superintendent by June 1.

**KEY:**

**A RATING OF 1 OR 2 REQUIRES A COMMENT.**

1. **Unsatisfactory** – Performance is clearly below the level of acceptability. The Superintendent has not kept pace with changing requirements or job performance is spasmodic or deteriorating seriously.
2. **Needs Improvement** - Performance is below expected levels of the position and/or lacking in important result areas.
3. **Satisfactory** - Performance meets expected standards and results are achieved. The required skills and knowledge are in evidence, and occasionally performance exceeds job requirements.
4. **Above Average** - Performance is consistently above established standards and job knowledge clearly exceeds requirements.

**A. Communication**—Able to communicate clearly with staff, parents, students and community, both verbally and in writing.

- \_\_\_ Conducts meetings of administrators, teachers and other staff members as necessary for the discussion of matters concerning the improvement and welfare of the schools.

**B. Community Relations**—Recognizes the importance of both stimulating and reflecting community needs/wants regarding education. Demonstrates ability to involve the community in developing and implementing goals. Views the community/school relationship as a partnership.

**C. Curriculum**—Strong commitment to leading the effort to define and deliver an effective, consistent curriculum pre-K-12.

\_\_\_ Conducts reviews of the total school program, and advises the Board on recommendations for the educational advancement of the schools.

**D. School/Community Involvement**—Visible in the schools, aware of current issues and activities in the schools, and shows an interest in community affairs.

**E. Leadership**—Able to motivate, lead, guide and direct people. Committed to implementing the Mission and Vision Statement of the school system.

\_\_\_ Serves as the educational leader of the school system. Performs job responsibilities using the Mission and Vision Statement as a guide.

**F. Organizational Management**—Uses a systematic approach to managing and improving the schools. Excellent organizational skills, working knowledge of school law, and proven ability to resolve organizational conflicts.

- \_\_\_\_\_ Administers, as chief school executive, the development, maintenance, and improvement of the educational program.
- \_\_\_\_\_ Maintains, directly or through delegation, such personnel records, pupil accounting records, business records and other records as required by law and/or Board policy.
- \_\_\_\_\_ Files, or causes to be filed, all reports required by state or federal laws/regulations.
- \_\_\_\_\_ Advises the Board of the need for new and revised policies, and ensures that all policies of the Board are implemented.
- \_\_\_\_\_ Makes administrative decisions necessary for the effective and efficient operations of the schools. Acts on own discretion when emergency action is necessary in matters not covered by Board policy. Reports such emergency actions to the Board and recommends policy for future guidance.
- \_\_\_\_\_ Develops and implements rules and procedures for staff and students as necessary to comply with Board policies, and state and federal laws/regulations.
- \_\_\_\_\_ Delegates to other staff, at own discretion, the exercise of any powers and duties, with the knowledge that such delegation does not relieve the Superintendent of final responsibility for any actions taken.
- \_\_\_\_\_ Recommends attendance boundaries for all schools and the transfer of students from one building to another in the interest of good administration of the instructional program. Implements Board policies and state laws/regulations for the promotion, retention and acceleration of students.
- \_\_\_\_\_ Makes recommendations to the Board concerning the transportation of students in accordance with Board policies, state laws/regulations, and student safety considerations.

**G. Personnel Management**—Excellent people skills. Ability to recruit and retain high quality staff. Strong personnel management practices and understanding of collective bargaining issues.

- \_\_\_\_\_ Develops and implements a hiring process that complies with applicable state and federal laws and attracts the most qualified candidates.
- \_\_\_\_\_ Nominates to the Board for employment the most qualified and competent teachers and administrators.

- \_\_\_ Handles employee grievances or problems in accordance with applicable Board policies, collective bargaining agreements, and/or state/federal laws and regulations.
- \_\_\_ Establishes and implements personnel policies and procedures for non-union staff.
- \_\_\_ Ensures that the Board complies with (meet and consult requirements) concerning educational policy issues.
- \_\_\_ Establishes personnel procedures that provide information that may be used to advance the quality of the school system, such as exit interviews for departing employees, employee focus group discussions on specific aspects of job performance and duties, questionnaires and/or other means of eliciting staff member feedback.

**H. School Facility Management**—Good understanding of facilities management, including development of long-term maintenance plans, and budgeting/planning for future building needs.

- \_\_\_ Makes recommendations to the Board on the location and size of new school sites and additions to existing sites; the location and size of new buildings on sites; plans for new school buildings; appropriates for sites and buildings; and improvements, alterations and changes in buildings and equipment.
- \_\_\_ Develops and implements short and long-term maintenance plans for school buildings and grounds, delegating particular duties as the Superintendent deems appropriate.

**I. School Finance/Budgeting**—Strong working knowledge of school finance, including budget development and management. Ability to effectively communicate with the Board, staff, community and local municipal officials. Clear understanding of federal, state, and local funding issues.

- \_\_\_ Demonstrates the ability to perform effective financial forecasting and long and short-term financial planning.
- \_\_\_ Supervises the preparation and presentation of the annual budget and recommends it to the Board for approval.

- \_\_\_ Establishes and maintains efficient procedures and effective controls for all expenditures of school funds in accordance with the adopted budget.
- \_\_\_ Clearly explains proposed budgets, needs and priorities to the Board, community and local municipal officials.
- \_\_\_ Conducts all financial operations and purchasing within Board policies and applicable state/federal laws/regulations.

**J. School Improvement**—Commitment to supervise and evaluate school programs in the spirit of continuous improvement; understanding of educational practices, research, and national/state/local initiatives, including Maine’s Learning Results; and ability to frame issues for discussion, reach timely decisions, and implement change.

**K. Staff Development**—Committed to and fosters continuous staff improvement. Emphasizes both system wide and individual development.

- \_\_\_ Fosters an environment that encourages continuous learning and improvement on the part of school staff.
- \_\_\_ Develops and implements an effective system of staff development focused on improving the educational and operational programs of the schools, with appropriate input from the Board, administration and staff.

- Provides reasonable opportunities for staff to participate in conferences, visitations and coursework within the framework of the school system's budget.
- Ensures that all staff are involved in the school system's staff development opportunities.
- Informs the Board of staff development priorities, needs, and activities.

**L. Superintendent/Board Relations**—Understands that the Superintendent is responsible for management of the schools under the Board's policies and is accountable to the Board. Supports and facilitates the work of the Board. Maintains open communication with the Board.

- Supervises and ensures compliance with all laws, regulations and Board policies.
- Keeps the Board informed about programs, activities, accomplishments, problems, and needs of the schools.
- Presents information and recommendations necessary to assist the Board in performing its duties effectively, including the need for policy on particular subjects.
- Schedules and attends meetings of the Board.
- Serves as Secretary to the Board as required by law.
- Serves as an ex officio member of all school system/Board committees, attending meetings as specified by the Board.
- Advises and recommends action by the Board as appropriate concerning student and staff disciplinary issues.
- Assists the Board in developing annual and long-range goals for the school system.
- Represents the school system with the media and other groups as deemed appropriate by the Board.
- Performs such other tasks as may be assigned by the Board.

**M. Supervision/Evaluation**—Understands the importance of accountability for staff and self. Uses an evaluation process that establishes clear performance standards and follows through to resolve performance issues.

- Oversees methods of teaching, supervision, evaluation and administration in the schools.
- Disciplines employees as necessary and reports such actions to the Board as appropriate.
